

COMPETITION TERMS AND CONDITIONS

The INEOS Automotive x Manchester United Prize Draw (the "Competition") is organised by:

INEOS Automotive Limited, a company incorporated in England with company number 11201576, whose registered address is at Hawkslease, Chapel Lane, Lyndhurst, Hampshire, United Kingdom, SO43 7FG, and whose main trading address is at Anchor House, 15-19 Britten Street, London SW3 3TX ("**INEOS Automotive**").

References to "Affiliates" in these Competition Rules means any other person or legal entity directly or indirectly controlling, controlled by or under common control with INEOS Automotive.

References to "Manchester United" in these Competition Rules are references to Manchester United Football Club.

This Competition is subject to the following terms and conditions ("Competition Rules"). It is the responsibility of each entrant to ensure that they have read and abide by the Competition Rules.

ELIGIBILITY CRITERIA

- Entrance is restricted to persons who have access to the internet and have completed the INEOS
 Automotive x Manchester United form linked in 7.a. In addition, to meet the criteria for this
 Competition, entrants must:
 - a. Be aged 18 or over by Wednesday 23rd July 2025; and
 - not be an employee, contractor, or consultant of INEOS Automotive or its Affiliates, or Manchester United, involved with the organisation or judging of the Competition, or a family member of any such employee, contractor, or consultant.
- 2. Subject to paragraph 1, the Competition is open to entrants in the United States of America and the United Kingdom.
- 3. Only one (1) entry may be submitted per person.
- 4. Entrants agree to receiving communications from INEOS Automotive in relation to this Competition using the details they provided.

HOW TO ENTER

- The Competition will run from 00:01 (British Summer Time) on Wednesday 23rd July 2025 ("Opening Date") and will close at 23:59 (British Summer Time) on Wednesday 6th August 2025 ("Closing Date"). No entries can be accepted after the Closing Date.
- 6. On the opening date, Manchester United will send an email to contacts who have opted in to receive marketing emails from Manchester United and whom are residents in the United States of America or United Kingdom, inviting them to enter the competition with a link to the competition form in paragraph 7.a.
- 7. In addition to fulfilling the eligibility criteria above, entrants must:
 - a. complete all fields on the dedicated Competition form, which is accessible via; https://staging.ineosgrenadier.com/en/gb/manchester-united-competition
- 8. There is no purchase necessary to enter the Competition, or to be eligible for the Prize.
- 9. By entering the Competition, entrants and winners agree to be bound by these Competition Rules.

THE PRIZE

 INEOS Automotive are offering one (1) eligible entrant the chance to win one (1) piece of Manchester United merchandise to be signed by one or more members of the Manchester United squad (the "Prize").



- 11. The Prize does not include any travel, accommodation or any other expenses. INEOS Automotive will bear the cost of delivery and customs charges; however, any other additional costs incurred that are incidental to the fulfilment of the Prize are the responsibility of the winner.
- INEOS Automotive reserves the right to substitute the Prize to a reasonable equivalent of equal or greater value.
- 13. The Prize is not negotiable or transferable and must not be sold onto a third party or otherwise disposed of following receipt of the Prize.

SELECTION PROCESS

- 14. INEOS Automotive will export the names of those who provided eligible responses into a Microsoft Excel document and each eligible entrance will be assigned a number.
- 15. The value range will be entered into Google's Random Number Generator functionality and one (1) number will be selected at random.
- 16. From the one (1) number selected, the assigned winning entrant is confirmed.
- 17. INEOS Automotive's decision is final as to whether an entrant is eligible to participate in the Competition.

THE WINNER

- 18. INEOS Automotive will contact the winner as soon as practicable using the details provided by the winner at the time of entry.
- Once the winner has been selected, the decision is final, and no discussion or correspondence will be entered into.
- 20. Details of the Selection Process (paragraphs 14-17 above) shall be made available to anyone requesting such information by letter to the trading address above for one (1) month after the Opening Date.
- 21. INEOS Automotive will make available information that indicates that a valid award took place. To comply with this obligation INEOS Automotive will send the surname and county of the winner to anyone who emails partnerships@ineos.com, or writes to the trading address set out above within one (1) month of the Closing Date of the Competition.
- 22. If the winner objects to any or all of their surname or county being published or made available, please contact INEOS Automotive via <u>partnerships@ineos.com</u>. In such circumstances, INEOS Automotive must still provide the information and winning entry to the Advertising Standards Authority on request.

CLAIMING THE PRIZE

- 23. INEOS Automotive will contact the winner via the email provided in Competition form no later than Wednesday 13th August 2025.
- 24. The Prize may not be claimed by a third party on behalf of the winner.
- 25. From the time of initial contact by INEOS Automotive, winner will be granted a period of five (5) days to claim the Prize, after which the Prize will be allocated to another entrant (via the Selection Process outlined in paragraphs 14-17), who will be contacted by an INEOS Automotive representative (nullifying the original winner's right to claim the Prize).
- 26. INEOS Automotive does not accept any responsibility if you are not able to take up the Prize.

GENERAL

27. Any breach of the Competition Rules may result in an entry being voided. Additionally, any entry found not to comply with the Competition Rules at any stage of the Competition may be disqualified. No allowances will be made in the event of disqualification, and any prizes will be forfeited. If a breach has occurred, but is discovered after an award, INEOS Automotive may



- require the return or reimbursement of any prize already received. Any decision of INEOS Automotive's relating to the Competition is final and binding. No negotiation will be considered, and INEOS Automotive will not enter into subsequent correspondence regarding such decisions.
- 28. Neither Manchester United, INEOS Automotive, or its Affiliates shall, under any circumstances be responsible for any of the winners' costs and expenses incurred in relation to this Competition, including, but not limited to, travel, subsistence and accommodation costs and expenses. Additionally, Manchester United, INEOS Automotive, and its Affiliates shall not reimburse any of the winners' costs and expenses in the event of disqualification of the winner or the winner is refused permission to participate in the Prize for any reason, or in the event the Competition is cancelled.
- 29. Entrants accept that, to the extent permitted by law, they are liable for all personal injury and all damage caused to their property or the property of others whilst participating in the Prize and any activities associated with the Prize and the Competition.
- 30. Entrants accept that they must comply with any requests made by, and will abide by all rules, terms and conditions, safety information, procedures and instructions provided to them by INEOS Automotive or any of its Affiliates or Manchester United. Failure to do so may result in the entrant's immediate exclusion from the Prize, without compensation or reimbursement.
- 31. All Intellectual Property Rights relating to materials created by INEOS Automotive and its Affiliates for the purpose of this Competition shall be the sole and exclusive property of INEOS Automotive. Also, entrants must agree to licence any relevant Intellectual Property to INEOS Automotive for the duration of the Competition.
- 32. Any personal data relating to entrants will be used solely in accordance with applicable data protection legislation and INEOS Automotive's Privacy Notice.
- 33. If any terms and conditions of these Competition Rules are deemed invalid, illegal, or otherwise unenforceable, they shall be severed from these Competition Rules and the remaining clauses will remain in force.
- 34. INEOS Automotive reserves the right to cancel, amend, terminate, or temporarily suspend this Competition in the event of any circumstances outside INEOS Automotive's reasonable control.
- 35. These Competition Rules are governed by the laws of England and Wales and are subject to the exclusive jurisdiction of the courts of England and Wales, which entrants agree to submit to when entering this competition.
- 36. Winners release, hold harmless and indemnify Manchester United, INEOS Automotive and its Affiliates and their employees, contractors and directors, to the extent permitted by the law, from and against all claims, demands, actions, liabilities, costs and expenses in respect of any injury the winner may suffer, the winner's death and/or any and all loss or damage to the winner's or a third party's property arising out of or in connection with their attendance at and/or participation throughout the duration of the Prize.
