Competition Rules

The "INEOS Grenadier / Hard Way Home" (the "Competition") is organised by:

INEOS Automotive Limited, a company incorporated in England with registered number 11201576 and registered address at Hawkslease, Chapel Lane, Lyndhurst, Hampshire, United Kingdom, SO43 7FG ("**INEOS Automotive**") whose main trading address is at Anchor House. 15-19 Britten Street, London SW3 3TX.

References to "INEOS" in these Competition Rules are to INEOS Automotive Limited (or such other member of the INEOS Group as may be applicable ("Affiliates"). "INEOS", "Grenadier" and "INEOS Automotive" are trading names of INEOS Automotive Limited.

ELIGIBILITY CRITERIA

- 1. The Competition is conducted subject to these "Competition Rules". It is the responsibility of each entrant to ensure that they have read and abide by the Competition Rules. INEOS' decision is final as to whether an entry is eligible to participate in the Competition.
- 2. Entrance is restricted to persons who have access to the internet and have received the invitation email. In addition, entrants must meet the following criteria for this Competition:
 - a. have ordered an INEOS Grenadier by 31st August 2022.
 - b. be residents of either the United Kingdom or Europe.
 - c. are aged 18 or over by 31st August 2022;
 - d. hold / be willing to apply for an International Driving Permit 1968 (IDP), permitting the entrant to drive an INEOS Grenadier on public roads at an undisclosed location.
 - i. if not already held, a successful IDP application mandatory to be considered for competition entry progression;
 - e. must not have been convicted of any driving-related offences (including DUI) in the past 5 years
 - f. hold a valid passport, permitting the entrant to travel internationally:
 - entrants agree to make INEOS Automotive aware of any countries into which their passage is not authorised at the earliest stage possible;
 - g. be willing to obtain the necessary medical accreditation to travel internationally:

- 5. Entrants accept, to the extent permitted by law, that they may be liable for all personal injury, all damage caused to their property or the property of others whilst participating in any / all competition-related activities: However, INEOS will cover all reasonable and documented costs for the refurbishment/repair of any damage caused to the entrant's vehicle that occurs throughout the duration of any activities directly linked to the competition:

HOW TO ENTER

- 7. The Competition will run from 00:01 on 25th August 2022 ("Opening Date") and closes at 23:59 (Greenwich Mean Time) on 31st August 2022 ("Closing Date"). Please make sure that you allow enough time to complete your entry. No entries can be accepted after this time.
- 8. In addition to fulfilling the eligibility criteria above, entrants must:
 - a. Complete fields on the dedicated Competition form accessible through the invitation email; and
 - b. Correctly answer the questions.

INEOS will provide those winning entrants with flights, hotels, and meals for the purposes of participating / throughout the duration of competition-related activities (the "Prize").

- 11. INEOS reserve the right to substitute the Prize to a reasonable equivalent of equal or greater value.
- 12. The Prize is not negotiable or transferable and must not be sold onto a third party or otherwise disposed of following receipt of the Prize.

SELECTION PROCESS

- 13. INEOS Automotive will appoint a panel of 4X4 experts ("the Panel") that will consider your entry. Within five (5) days following the Closing Date, a shortlist of six (6) entrants will be invited to attend a Grenadier introduction off-road experience day in the UK.
- 14. On the Grenadier introduction off-road experience day, a film of driving highlights and interviews with each entrant will be created to share on INEOS Grenadier social media channels.
- 15. INEOS shall release details of the six (6) finalists on Grenadier social channels, inviting our community of fans and followers to vote for those they want to see complete the Hard Way Home.

THE WINNERS

- 16. INEOS will contact the winners as soon as practicable and ahead of the Publication Date (using the details provided by the winner at the time of entry.
- 17. Once selected the decision is final and no discussion or correspondence will be entered into. CLAIMING THE PRIZE

From the time of initial contact / outreach by INEOS Automotive, Winners will be granted a period of five (5) days to claim their prize, after which the prize will be allocated to another entrant who will be contacted by an INEOS Automotive representative (nullifying the original Winners' right to claim the prize).
